In particular, we will contribute to initiatives that seek to address operational excellence and sustainability.


To further these objectives, Instro Precision so far as is reasonably practicable commits to:

- Establishing a team approach to detection, prevention and problem solving.
- to consult with our employees on matters affecting their health and safety.
- to provide and maintain safe equipment and environment.
- Setting and reviewing measurable objectives and ensuring those objectives are met.
- Providing the necessary resources and ensuring responsibilities and authorities are determined and communicated throughout Instro Precision;
- Reducing the consumption of materials in our operations. We will reuse rather than dispose
 whenever possible and promote recycling and the use of recycled materials.
- to ensure that all workers are competent to do their work, and to give them appropriate training.
- to actively manage and supervise health and safety at work.
- Empowering employees to question processes which appear to produce discrepancies and acknowledging any improvements and contributions.

To help achieve our objectives and ensure our employees recognise their duties under various legislation whilst at work, we will also inform them of their duties to take reasonable care for themselves and for others who might be affected by their activities.



These commitments apply to all employees of Instro Precision, our suppliers and subcontractors (where appropriate). Additionally, we undertake to use our best endeavors to ensure that our business partners also abide by this policy.

Senior management is responsible for ensuring compliance with this policy, including but not limited to the establishment of programmes and compliance with reporting requirements. Quality, Sustainability, safety and security however, is the responsibility of all of us, at every level within our organisation.

The Managing Director of Instro Precision is ultimately responsible for this policy and the company's quality performance and is assisted by the management team, which oversees the implementation of all quality procedures and programs within Instro Precision.
