

## **UK REACH COMPLIANCE DECLARATION**

On the 1<sup>st</sup> January 2021, the BREXIT Transition Period came to an end and the UK REACH and the EU REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals) regulations that concerns chemicals and their safe use started to operate independently from each other.

As part of our ongoing commitment to compliance, Instro Precision manages a UK REACH program to identify which, if any substances of very high concern (SVHC) within the scope of Annex 14 (Annex XIV) of UK REACH are contained within the product supply chain and in what concentrations. Instro Precision also monitors the ongoing amendments to Title 8 (Annex XVii) of UK REACH, which introduced restrictions for specific applications.

Included as part of Instro Precision's UK REACH program we:

- Review & monitor internal and/or publicly available engineering data in relation to the presence of SVHC's in our products or any of their components;
- Review & monitor (where available) material composition information for all our materials;
- Communicate with our suppliers to confirm and where possible exclude the presence of SVHC's in any components used in our products.

Instro Precision can confirm under Title 4 (article 33) of UK REACH Regulation SI 1577/2020 the following status:

Instro Precision manufactured product(s), as well as any articles\* contained within the product(s),
 <u>DO NOT CONTAIN</u> REACH SVHCs in concentrations above 0.1%w/w.

Instro Precision can also confirm under Annex 13 of UK REACH Regulation SI 1577/2020 & Annex 1 of the The Classification, Labelling and Packaging of Chemicals (Amendments to Secondary Legislation) Regulations SI 21/2015 the following status:

• Instro Precision manufactured product (see annex A) contained SVHS below 0.1w/w.

This statement confirms compliance to the latest version of UK SVHC candidate list as of 22<sup>nd</sup> October 2020 with 303 substances of very high concern & 97 substances on the Authorisation List.

In addition, if or where required Instro Precision confirms as part of article 7 (2) of UK REACH our responsibility to notify the Agency (HSE) if any articles that are present in articles totalling over 1 tonne per year; <u>and</u> substances in those articles above a concentration of 0.1 % w/w. No such notification is required by Instro Precision.

Instro Precision Limited will endeavour to appropriately update or modify this REACH Compliance Statement should any changes occur in the composition of Instro Precision products or the REACH regulations, including the addition of any substances to the SVHC Candidate List, the Authorisation List or Title 8 (Annex XVII) of the UK REACH regulations.
